Background

The Australian Humanitarian Partnership (AHP) is a five-year partnership between the Department of Foreign Affairs and Trade (DFAT) and six Australian NGOs and their consortia designed to provide rapid support to emergencies, assist in protracted and slow-onset crises, and build humanitarian capability and community resilience in the Pacific. The lead NGOs are CARE Australia, Caritas Australia, Oxfam Australia, Plan International Australia, Save the Children Australia, and World Vision Australia. All of the NGOs except for Save the Children also have consortium members which will be involved in the AHP. Oxfam Australia is in a consortium with ABC International Development and CBM.

Scope of Position

Oxfam Australia (OAU) is one of the most influential international social justice organisations in Australia and part of one of the most effective international confederations of aid and humanitarian agencies.

In more than 90 countries, we are working towards a better, more equal world for all of us - where women and men can use their own ideas, voices and actions to build a future free from the injustice of poverty. Oxfam delivers long term development

programming, humanitarian responses and practises high level advocacy and campaigning.

Oxfam Australia is an innovative rights-based agency that leads development debates and practice, works to influence government policy in Australia and around the globe to improve the lives of poor people, and has a strong focus on human rights.

Through the AHP Oxfam is responding to the COVID-19 pandemic and additional disasters regionally in the Pacific and in five specific countries: Solomon Islands, Vanuatu, Timor-Leste, Papua New Guinea, and Fiji.

Under the AHP Disaster Ready program Oxfam seeks to focus on strengthening the ability of local communities and organisations in the Pacific to prepare for and respond to disasters. Oxfam is delivering this program regionally and in four countries: Solomon Islands, Vanuatu, Fiji and Timor-Leste.

Key Responsibilities

- Manage the overall Disaster Ready program for Oxfam across Solomon Islands, Vanuatu, Fiji, Timor-Leste and the Pacific region, including brokering technical and sectoral expertise, leverage additional funds, and track the implementation and financial aspects of the program.
- Manage the AHP responses in the Pacific region and Timor-Leste, including brokering technical and sectoral expertise, leverage additional funds, and track the implementation and financial aspects of the program
- Broker technical and sectoral expertise and facilitate internal coordination within Oxfam, including leading internal meetings, and ensuring clear communication and information sharing processes are in place for Oxfam staff, and all relevant stakeholders are kept up-to-date.
- Leverage additional funds for disaster resilience and response in the Pacific.
- Represent OAU in the Australia-based humanitarian sector, including with DFAT and key sector partners.
- Lead OAU sector and donor advocacy and engagement on the localisation agenda, including leading ACFID HRG working groups and engaging with OI colleagues.

Travel

Regular international and interstate travel of approximately 12weeks per year is a requirement of the position. It is a condition of employment that staff abide by all agency security and safety protocols, policies and procedures and the Oxfam International Security Protocol.

Child Safeguarding

As an agency undertaking work both nationally and internationally and in humanitarian response, OAU takes its duty of care seriously to safeguard children and youth and recognises that it must meet community expectations and the trust placed in its staff and associated personnel to maintain the highest standards of conduct with children and youth.
